CONDITIONS

Applications for the 2016 Royal Edinburgh Military Tattoo (REMT) in Wellington, New Zealand Highland Dance Team are now being accepted.

The 2016 Dance Team will comprise of 25 Scottish Official Board of Highland Dancing (SOBHD) dancers and 25 NZ Academy dancers who will be joined by 20 dancers from Scotland. There will also be two reserve dancers from New Zealand.

NZ Academy will appoint 25 dancers plus 1 reserve, and will also have a standby list.

The Tattoo will take place from 18 - 21 February 2016. Dancers must arrive in Wellington no later than the evening of Monday 15 February for rehearsals prior to performance commencing and depart on Monday 22^{nd} February.

Applicants must be 14 years or over as at 1 January 2016 and must be of Premier Standard which must be maintained throughout the year. Applications from both male and female dancers will be considered.

Minors applying and accepted, will be given further information as to chaperone requirements during rehearsals and performances.

Dancers must maintain a level of fitness to enable them to perform at a high standard. Should you be selected, your Dance Teacher will be contacted to confirm your regular attendance at classes.

All dancers who make the final team will be required to have a long sleeved jacket to wear with their kilt.

Dancers are responsible for all travel costs to and from Wellington. Lunch and dinner will be provided for all dancers on the two rehearsal days in addition to dinner on the four performance days. Those dancers based outside of Wellington will also receive \$20 NZD per day towards accommodation costs. Accommodation will not be provided by the Tattoo for any NZ dancers.

The Dancers are under the direction of Aileen Robertson, the Highland Dance Director for the Royal Edinburgh Military Tattoo. The Dance Director's decision is final.

SOBHD technique will be used in all choreography which all dancers, both NZ Academy and SOBHD, will be required to learn.

A full length photograph in your kilt outfit should be included with your application. This must be a recent photograph, taken within three months of submission of your application.
